DEFINITIONS

Beta is a measure of the volatility—or systematic risk—of a security or portfolio compared to the market as a whole. Standard Deviation measures the dispersion of a dataset relative to its mean. Sharpe Ratio consists of taking the excess return of a portfolio, relative to the risk-free rate, and dividing it by the standard deviation of a portfolio’s excess returns, providing a measurement of a portfolio’s outperformance per unit of a portfolio’s volatility. Information Ratio is a measurement of portfolio returns beyond the returns of a benchmark, usually an index, compared to the volatility of those returns.






Market Capitalization
